RE: Monthly Report for May 2021 (May 24, 2021-meeting @ 1930 hours)

### I. Equipment:

- a. We have received the new Ford 2020 SUV (Police rated) and it was issued to Sergeant Edwards KC #89. Sgt. Edwards's prior assigned (fully operational police vehicle) was reassigned to Corporal Owens KC#80.
- b. We have also received a new drone which is an DJI Mavick 2 Enterprise, the drone will be deployable once all administrative guidelines are in place, and presently we have an updated policy which has been submitted to the CT DESPP for review and approval.

#### Officer Training:

a. All our Officers have been POSTC recertified and have completed firearms annual training. Sgt. Edwards is currently in the process of assuring that all Colchester Police officers are in compliance with the Police Accountability act of 2020 and is implementing both psychological screenings and drug screenings as part of the new police act.

### II. Initiatives:

- a. RX Drug drop box. Renewed Drug Drop Box. It should be noted that we are regularly receiving Pharmaceutical Prescription Drugs dropped off at our facility.
- b. Officers have been fingerprinting individuals for background checks and pistol permit applicants for town residents-since the loosening of COVID restrictions however are still following all State and local CDC guidelines regarding COVID precautions.
- c. Officers are conducting visibility/enforcement patrols at numerous locations within the town and the Speed Trailer is currently deployed on Rte. 16 in the area of Buckley Road.
- d. Notable Investigations: Case # CFS 2100158242- Commercial Burglary at Goldi- Locks Self Storage (359 Lebanon Avenue, Colchester) with approximately two hundred thousand dollars of damage to the facility. The case/investigation was turned over to CT State Police Major Crime detectives and the investigation is pending- there were two stolen motor vehicle occurrences so far in the month of May.
- Will be actively researching prospective locations within the town of Colchester for a pistol/rifle range for the PD.
- f. COFFE WITH A COP will resume in JUNE 2021- with the availability of outdoor dining at several business establishments in town, it will be great to reach out to the town's citizens, meet and greet them while listening to and addressing their concerns while being safe in an outdoor environment.

#### III. OTHER-

- ALL Colchester Police Corporals have been continuously conducting their extra administrative and operational duties which helps maintain the Police Department in an excellent state of operational readiness.
- -Corporal Labonte KC 87 has submitted his letter of intent to retire as of July 30th, 2021.
- -All Colchester PD officers have been issued proper PPE for any blood borne pathogen potential exposures and COVID exposures-including a sharps kit. All Colchester PD officers have also received a copy of the Bloodborne Pathogen Exposure Control Plan as it pertains to DESPP A&O section 4.13.1.
- -We are progressing with the Colchester PD hiring process and at the present time we have approximately 4 police applicants left in the process and the applicants are currently in the "background phase" of the hiring process.
- -Lastly, I have submitted my CT State Police retirement paperwork with a tentative retirement date of 10/01/2021, and I will continuously make every effort to keep improving the Colchester PD and the service we provide to the Town prior to my departure.
